1 INTRODUCTION

This report provides a summary of environmental monitoring results for Mount Thorley Warkworth (MTW) in accordance with the requirements of the following Environment Protection Licences (EPL):

- EPL24 Mount Thorley Coal Loader (MTCL);
- EPL1376 Warkworth Mining Limited (WML); and
- EPL1976 Mount Thorley Operations (MTO).

This report includes all monitoring data collected in accordance with the above licences for the period 1 to 31 October 2024.

Monitoring in this report includes:

- Air quality monitoring;
- Surface water monitoring including mine water discharge and effluent quality; and
- Blast monitoring.




Figure 1: Mount Thorley Warkworth Environmental Monitoring Locations

Monitoring locations are shown in **Figure 1**.

2 AIR QUALITY

In accordance with the requirements of Condition M2.2 of WML EPL 1376 and MTO EPL 1976, MTW maintains a network of five PM_{10} monitors.

Results of Particulates (PM_{10}) monitoring are shown in **Table 1**. Results reported represent the 24hr average PM_{10} , derived from 10 minute PM_{10} values for the period midnight to midnight, for each calendar date during the reporting period. The last sampling date was 31 October 2024 and the data was obtained on 1 November 2024.

3 SURFACE WATER

3.1 Mine Water Discharge Monitoring

MTW participates in the Hunter River Salinity Trading Scheme (HRSTS) and maintains two monitoring locations associated with this scheme.

4 BLAST MONITORING

In accordance with the requirements of Conditions M7.1 (WML EPL 1376) and M8.1 (MTO EPL 1976), MTW maintains a network of blast monitors to measure airblast overpressure and ground vibration for all blasts carried out at MTW. Blast monitoring results are detailed in **Table 6** (Airblast Overpressure) and **Table 7** (Ground Vibration). The last date sampled was on 30 October 2024. The data was obtained on 31 October 2024.
